Members must be in good standing with the AKC and comply with all AKC rules and regulations. Members, as representatives of CKC, shall at all times, act solely in the best interests of the club in a manner consistent with high standards of conduct and ethics. Members shall refrain from unnecessary criticism of another person, their dog, and/or breed. Dogs owned by, or in the care of, members shall be provided a proper, safe and healthy environment.

DESCRIPTION OF CLUB ACTIVITIES

CONFORMATION: CKC offers classes in conformation to assist students in developing or improving their handling skills, to give a new dog experience in the ring, and provide “run throughs” for practical experience. You can get involved as an Instructor/Assistant Instructor, or practice “Judge”.

OBEDIENCE: To further proper socialization of puppies and dogs, CKC offers general obedience classes for Puppies (3-12 months), Basic and Advanced Basic levels. We also offer Novice, Open, and Utility levels for individuals interested in obedience competitions.

RALLY: Classes prepare students for AKC Rally competitions by developing an understanding of AKC Rally rules and regulations, proper sign performance, and ring etiquette.

NOSE WORK: Classes to encourage a dog's natural instincts to sniff and use their nose to search for food to enhance a good relationship as a handler/dog team.

AKC LICENSED SHOWS: We provide two AKC licensed conformation shows, multiple obedience/rally trials, and one “B” conformation match annually. Volunteers are needed to support these events in every imaginable capacity – e.g. ring stewards, parking attendants, judges’ hospitality/transportation, show site preparation, clean-up, etc.

NEWSLETTER: Our newsletter is a primary communication vehicle along with our monthly club meetings. Club members serve as editors and contributors.

PUBLIC EDUCATION: Public education to promote the proper care, treatment, and training of dogs is an important community service that CKC provides. You can get involved in many local events.

JUNIOR SHOWMANSHIP: Training classes for Junior Showmanship are conducted throughout the year, teaching proper show techniques and providing motivation for the development of junior handlers.

CANINE LEGISLATION: On occasion, we are called upon to represent the club and dog fanciers in the review and revision of regulations for local government. Representing the club on issues such as regulations for kennel licenses and animal control are key interests for the club.
